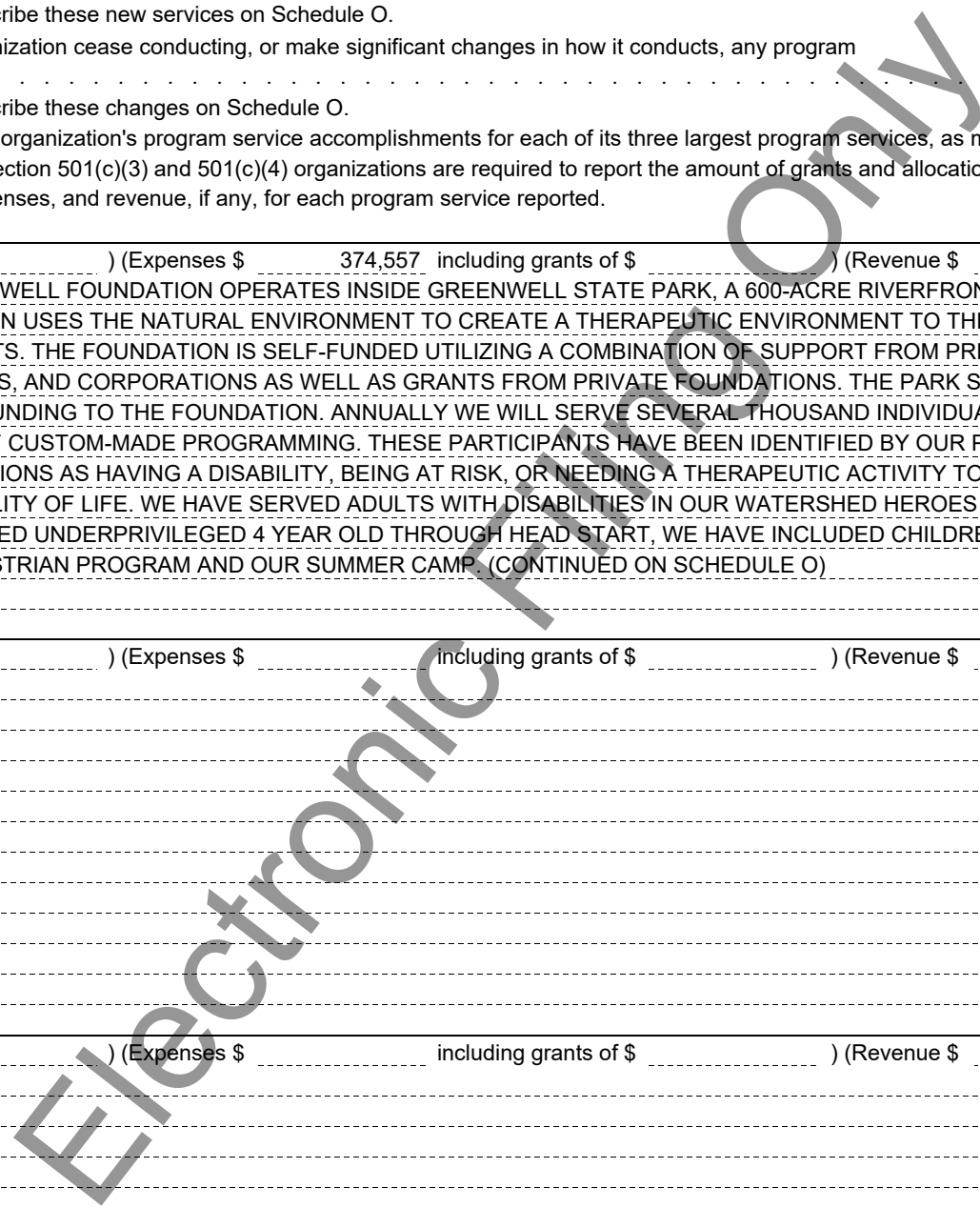

THE FOUNDATION USES THE NATURAL ENVIRONMENT TO CREATE A THERAPEUTIC ENVIRONMENT TO THE BENEFIT OF ALL OUR CLIENTS. THE FOUNDATION IS SELF-FUNDED UTILIZING A COMBINATION OF SUPPORT FROM PRIVATE DONORS, BUSINESSES, AND CORPORATIONS AS WELL AS GRANTS FROM PRIVATE FOUNDATIONS. THE PARK SERVICE DOES NOT PROVIDE FUNDING TO THE FOUNDATION. ANNUALLY WE WILL SERVE SEVERAL THOUSAND INDIVIDUALS IN A WIDE VARIETY OF CUSTOM-MADE PROGRAMMING. THESE PARTICIPANTS HAVE BEEN IDENTIFIED BY OUR PARTNER ORGANIZATIONS AS HAVING A DISABILITY, BEING AT RISK, OR NEEDING A THERAPEUTIC ACTIVITY TO IMPROVE THEIR QUALITY OF LIFE. WE HAVE SERVED ADULTS WITH DISABILITIES IN OUR WATERSHED HEROES PROGRAM, WE HAVE SERVED UNDERPRIVILEGED 4 YEAR OLD THROUGH HEAD START, WE HAVE INCLUDED CHILDREN AND ADULTS IN OUR EQUESTRIAN PROGRAM AND OUR SUMMER CAMP. 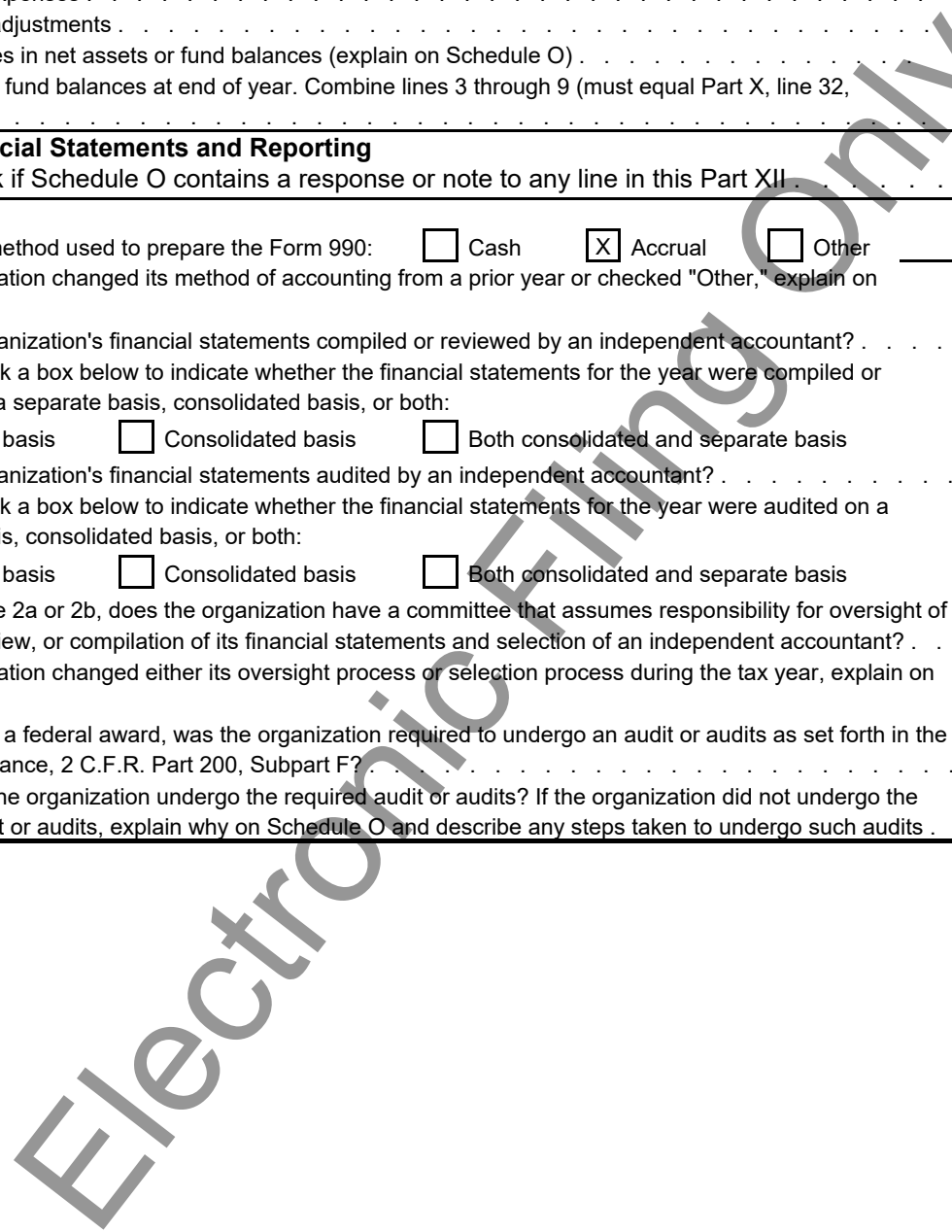
